BEEF MONTH BEEF EATERS CLUB SWEEPSTAKES OFFICIAL RULES

NO PURCHASE NECESSARY TO ENTER OR WIN. A PURCHASE DOES NOT INCREASE THE CHANCES OF WINNING. OPEN ONLY TO LEGAL RESIDENTS OF ILLINOIS WHO ARE 18 YEARS OR OLDER AT THE TIME OF ENTRY.

- 1. **HOW TO ENTER:** On a piece of 3" x 5" paper, print your name, complete mailing address (no P.O. Boxes), daytime phone number, and email address. Include with that paper a receipt from any restaurant physically located within the State of Illinois listing at least one (1) beef item, dated between May 1 and May 31 of the current year. Mail to: Illinois Beef Association, ATTN: Beef Eaters Club, 2501 N. 8th Street, Springfield, Illinois 62702. No mechanically reproduced or photocopied entries accepted. All participants limited to one entry per day during May 2025 (a total of 31 entries). Entries must be received by June 9, 2025, when the sweepstakes ends. Entries will still be accepted without including a receipt and will be eligible for any and all prizes, and the Entries become the property of Sponsor and will not be returned. Every entrant will receive a "Beef Eaters Club" sticker; limited to one (1) sticker per entrant.
